

**ACCESSORIAL CHARGES**

1. **Appointment Delivery Charge:** \$32.00. Charges apply to shipments which require a call to book an appointment prior to being delivered.
2. **C.O.D. charges:** 5% of C.O.D. amount, min \$50.00. The C.O.D. fee applies when our driver is asked to pick up any form of payment for the product being hauled, payable to the carrier, from the consignee on behalf of a third party.
3. **Cross Dock:** \$100.00/hour min \$75.00.
4. **Dangerous Goods Surcharge:** 5%, min \$10.30 max \$35.00.
5. **Deck Delivery Charge:** \$163.50 min, \$1.63/km round trip.
6. **Density:** Freight will move at no less than 10 lbs per cubic foot (pcf).  $10 \text{ pcf} = \text{length (in)} \times \text{width (in)} \times \text{height (in)} / 1728 \times 10$ . If this amount is more than the actual weight of the shipment, then the cubed weight would apply to calculate the freight charges. When a shipment is non-stackable, height is calculated to 96 inches.
7. **Doors & Glass/Loose Siding & Accessories:** Move at 2X actual weight or 10lbs per cubic foot, whichever is greater
8. **Excessive Length:** \$75.00/shipment containing pieces over 14ft in length.
9. **Extra Drop Charge:** \$125.00/ additional delivery. Charge applies when a customer requires more than one stop on a trailer otherwise designated as a trailer load. Any loads which require appointments or need to be spotted for unload will be charged as separate shipments.
10. **Extra Help:** \$27.25/30 min or portion thereof; minimum of 90 minutes. Charge applies when the driver requires a helper to load or unload the freight. It applies to the total time spent performing the work required, including travel time.
11. **Protection From Freezing:** October 1 to April 15, 10%; 0-10 000 lbs. min charge \$15.00, over 10,000 lbs min \$50.00.
12. **Inside or Non-adjacent Delivery:** \$27.25 plus detainment where applicable. Charge applies when any delivery service is required more than 60 feet from the delivery vehicle. This includes deliveries which require service to/from floors other than the ground floor and also mall deliveries, etc.
13. **Overhead Doors:** Move at 3X actual weight
14. **Personal Effects/ Used Goods/Inadequate Packaging:** Ship at Owner's Risk of Damage
15. **Power Tailgate Charge:** \$33.00 plus \$7.50/each additional use. Charge applies when the shipper or consignee does not have proper shipping/receiving docks to ensure safe handling and/or power tailgate service is stated as a requirement.
16. **Private Residence Pick-up or Delivery:** \$75.00 plus detainment where applicable in Calgary and Edmonton, other centers min charge \$40.00 plus detainment where applicable. Charges apply when service is required at property that is a private residence, whether the property operates as a business or not.
17. **Re-Delivery/2<sup>nd</sup> Pickup or Delivery:** \$4.00/cwt min charge \$40.00 max charge \$200. Charge applies when delivery/pickup attempts fail on first attempt for any of the following reasons:
  - a. Shipper/Consignee requests we come at another time because they are not ready for shipment.
  - b. No answer at shipper/consignee's place of business
  - c. Shipper/Consignee request we go to another address within the terminal service area of which we were not previously informed.
18. **Rural Delivery Charge:** \$80.00. Applies to any location outside of municipal boundaries.
19. **Saturday or Holiday Delivery (where available and pre-arranged):** \$175.00. Charge applies when Saturday/holiday delivery service is requested which is not part of our regular service and/or we are required to call a driver in to complete this service. Please contact your local Duckering's Transport branch to inquire about Saturday deliveries and branches that may not apply Saturday delivery charges.
20. **Scaling/Adjusting Overloaded Trailer:** \$200.00 full trailer load. Charge applies should the shipper overload a trailer or load too much weight on an axle and the trailer or load must be adjusted to be made legal and then rescaled.
21. **Storage Charge:** After 48 hrs \$1.00 per cwt /day min \$18/day. Shipments being stored that require protection from freezing shall be charged trailer demurrage.
22. **Tarping Charges:** \$200.00 per deck or portion thereof.
23. **Trade Show Delivery:** \$50.00 plus detainment where applicable.
24. **Trailer Demurrage:** First 24 hrs n/c thereafter \$70.00/day, \$240.00/week, or \$725.00/month. Charge applies when trailer is not unloaded at consignee within 24 hours of notification of availability.
25. **Valuation Charge:** 2% of the excess, \$2.00/lb on actual weight of shipment, min \$10.00. Charge applies when the customer indicates a declared value on the bill of lading indicating they would like more than \$2.00/lb protected in the case of loss or damage.
26. **Detainment:** Straight truck \$95.00/hour. Tractor \$115.00/hour. Charge applies when driver is detained at point of delivery/pickup more than 15 minutes for shipments < 5000lbs, 30 min for shipments > 5000lbs, and 60 min for shipments > 15 000. These are charge in 15 minute increments. Charges applied when a customer requires driving service on an hourly basis and are subject to fuel surcharges.
27. **After Hours Service:** \$87.50 (Service between 7pm – 7am.)
28. **Hot Shot Service:** \$115/hr on top of the customer's regular rate.
